

## “HIDEYO NOGUCHI AFRICA PRIZE”

### PURPOSE AND DESCRIPTION OF THE PRIZE

The spread of infectious diseases presents a common threat to all humankind. Mindful that Africa faces this scourge most acutely, the Government of Japan established the Hideyo Noguchi Africa Prize in July 2006 in memory of Dr. Hideyo Noguchi (1876-1929) whose belief in medical advancement and self-sacrificing activities in Africa remain a beacon of inspiration to all. Guided by these ideals and mindful of the ominous human suffering persisting in Africa, the region facing the most serious health challenge on the globe, the Prize aims to honour individuals with outstanding achievements in the fields of medical research and medical services to combat infectious and other diseases in Africa, thus contributing to the health and welfare of the African people and of all humankind.

The Prize consists of two categories: *Medical Research* honouring individual(s) and *Medical Services* honouring individual(s) or organization(s)

The Prize will be awarded every five years and the first award will be presented at the award ceremony scheduled in the first half of 2008.

The Prize consists of a citation, a medal and an honorarium of 100 million yen.

The selection process comprises two stages, namely: (a) recommendation of a maximum of three candidates by two sub-Committees, one established under the auspices of the Japan Society for the Promotion of Science (JSPS) and the other established under the auspices of the African Regional Office of the World Health Organization (AFRO), which will be responsible for the above-mentioned two categories respectively; and (b) finalization of the candidates(s) by the Hideyo Noguchi Africa Prize Committee to be referred to the Prime Minister for final decision.

### NOMINATION GUIDELINES AND REQUIREMENTS

#### 1. SCOPE

- Medical Research
  - Basic medical research
  - Clinical medical research
  - Research in all fields of bio-science closely related to medicine
  
- Medical Services
  - Field-level medical/public health activities to combat diseases and advance public health

## **2. ELIGIBILITY**

### **■ Medical Research**

- No distinction will be made according to nationality, age or gender.
- Nominee(s) shall be limited to people still living.
- Nominee(s) shall be in principle one individual per one research theme. However, in the case of a joint research, a maximum of three individuals will be considered.

### **■ Medical Services**

- No distinction will be made according to nationality, age or gender.
- Nominee(s) shall be limited to people still living. In case of organization(s), nominee(s) shall be limited to currently active organization(s).
- Nominee(s) shall be in principle one individual or one organization per one activity. However, under exceptional circumstances where more than one individual or organization work in a team, a maximum of three individuals or organizations will be considered.

## **3. NOMINATION/SELECTION CRITERIA**

### **■ Medical Research**

- The research has established original and/or milestone concepts for better understanding of the pathology or the human and environmental ecology of infectious or other diseases prevalent in Africa, or has improved (1) clinical management, (2) ecological management, (3) patient therapy relevant to such diseases;
- The research results have in practice contributed, or will contribute in the near future, to improving measures for controlling or treating infectious or other diseases prevalent in Africa.

### **■ Medical Services**

- The activity is aimed to fight against infectious or other diseases prevalent in Africa or improve public health in Africa;
- The activity has broad/direct impact on the improvement of health and welfare of the African people, particularly the poor;
- The activity has been carried out on-site for more than 5 years, under a defined goal and structured plan.

## **4. NOMINATION INFORMATION**

Please note that the evaluations of the contributions of the nominees depend heavily on the quality of information supplied in the nomination forms. Therefore, the nomination should be accurate, detailed, current and complete. Nominator and nominee cannot be the same person.

- Please present a brief biography including academic, administrative and research positions, awards or recognitions and identify main publications, if any.
- Please provide a short introduction and summary of the nominee's contribution in medical research or medical services in the context of the purposes of this Prize with a list of supporting publications or papers.

- Please outline how and why the research/activity of the nominee has contributed to the advancement and improvement of counter-measures against infectious and other diseases prevalent in Africa.
- Please arrange for supporting letters from colleagues familiar with the nominee's work, if any.
- Please prepare all documents in English.
- Please write your nomination within about 1,000 words (excluding the list of publications).
