At the 2nd Quality Assurance Committee Meeting, the member universities discussed assessment standards for comprehensive generic skills of students, such as 1. English proficiency, 2. intercultural knowledge competence, 3. fundamental competencies for working persons and 4. communication and, presentation capacity, as well as credit transfer and grade management. Criteria for 2. were created based on the American standard, VALUE Rubric. Criteria for 3, were developed based on the Japanese standards established by the Ministry of Economy, Trade and Industry. All member universities have agreed to develop their own criteria reflecting the characteristics of their own ASEAN country

■ Program Contents, Preparation for the Start of the Programs O Fostering Human Resources through the Industry of Central Japan

The member universities have highly rated a program that includes corporate internship based around Nagoya, home of the largest-scale industry in Asia (Toyota Motor Corp., etc.). Three member universities have additionally asked to join the internship program in AY2014.

SEND (Student Exchange Nippon Discovery) Activities

The students who experienced the SEND short-term program were motivated to learn even more in the long-term program, which is exactly what we hoped for the Campus ASEAN project. The students who joined the SEND long-term outbound program achieved great results in their coursework and internships at host universities. They learned the local languages, which helped them to introduce Japanese culture and language.

l Student Mobility

In AY2013, 56 Japanese students were sent to member universities, which exceeded the original plan. The number of participants for the Field Work in Cambodia has also increased. The number of SEND-related students was 16.

The 3rd quality assurance committee meeting, which included external commissioners from UNCRD and the private sector, was held to summarize the contents of bilateral meetings in AY2014 and discuss the credit transfer and grade management system in each university.

Establishment of Credit Transfer and Grade Management Systems

Necessary information, which included syllabi and curriculum, was shared among member universities. Also, academic staff from each university held discussions. Based on the discussion at the 1st and 2nd quality assurance committee meetings, credit transfer was successfully accomplished for all the students who participated in the exchange program during AY2013. It is expected that the credit transfer will also be smoothly accomplished for AY2014.

Establishment of Campus ASEAN Joint Education Course

Campus ASEAN Joint Education Courses were established for undergraduate and graduate students in all the faculties participating the project. The courses were provided in an omnibus form, which covers politics, economics, law, agriculture, and international development.

(Introducing Karate during SEND Program) O Fostering Human Resources through the Industries of Central Japan Implementing exchange programs with private companies in Nagoya allowed students to gain multifaceted practical knowledge, which included marketing, in addition to what they learned in the classroom. The program in AY2013 was highly appreciated by the member universities and it made the number of inbound students increase.

O SEND (Students Exchange Nippon Discovery) Activities

Although the main SEND activities used to be conducted only at educational institutions such as the Research and Education Center for Japanese Law located in the member universities, the area of activities was expanded in AY2014, such as teaching Japanese at NGOs. Moreover, the SEND longterm outbound students became able to do their overseas internships not only at law firms, but also at Japanese general trade companies and NGOs.

Understanding ASEAN Economics/Society/Culture

In addition to visiting private companies and governmental agencies, the short-term outbound students visited local NGOs/NPOs and conducted fieldwork in rural areas to hear various perspectives directly from local people. It helped them to understand the diverse aspects of ASEAN economics, society, and culture.

O Outbound

The project started sending students to Singapore National University in AY2014 in addition to the universities hosting Nagoya University students in AY2013. The number of students hoping to participate the short-term program has increased substantially since the program has become well known among the student body.

O Inbound

The number of inbound students increased by 2.5 times compared to AY2013 since the positive results of the internships based on academic-industrial alliance were shared among the member universities. With the participation of external commissioners from international organizations and business community, the 4th Quality Assurance Committee Meeting was held to report on the current state of the new grading system adopted in AY2015, known as the UMAP Credit Transfer Scheme (UCTS), and on Omnibus courses started in AY2014. The meeting allowed participants to exchange opinions on future visions of University to University international interactions.

Adopting New Grading System (UCTS)

In AY2015, the Graduate School of International Development in Nagoya University, Chulalongkorn University (Thailand), and University of the Philippines Los Baños (Philippines) agreed that in addition to their standard transcripts for long-term study abroad students, each university will also provide transcripts based on the new grading systems known as the University Mobility in Asia and the Pacific (UMAP) Credit Transfer Scheme (UCTS). The two types of transcripts will be used to transfer credits and have already been provided to returned students.

O Collaboration with Local Governments, Private Enterprises, and NPOs/NGOs With support from the ASEAN-NAGOYA CLUB, a private organization set up by Nagoya University graduates who have become successful business executives, international students received opportunities to experience and discuss Japanese culture and traditions and to participate in internships at private enterprises. Also, a short-term program was implemented with support from private enterprises in the Tokai region. The program participants attended lectures, exchanged opinions with enterprise staff and other students to learn about manufacturing and marketing. In addition, by increasing opportunities to collaborate with local governments in Aichi Prefecture, students could learn about public-private partnership. Moreover, students got opportunities to learn about the relationship between business and society by attending lectures on Corporate Social Responsibility (CSR) and Fairtrade given by staff members of NPOs/NGOs.

O SEND (Student Exchange Nippon Discovery) Activities

Japanese students introduced the Japanese legal system and culture in English in the Nagoya University's Research and Education Center for Japanese Law.
