2. Purpose of research

The purpose of this study is to examine and theorize the construction of social infrastructure essential for realizing a multicultural society from multiple approaches such as case studies, empirical studies, and international comparative studies. The starting point of this study is to recognize two different trends that have become apparent as globalization has activated the movement and contact of people from diverse backgrounds, such as race, ethnicity, culture, and religion. On the one hand, there is a movement to exclude different people such as xenophobia, anti-immigration and racism. On the other, it is the spread of international human rights norms and multiculturalism, and the establishment of institutions and norms of multiculturalism that recognize differences and coexist. This study does not consider the relationship between exclusion and inclusion as a separate issue, but rather focuses on institutions, structures, and norms as a social infrastructure that simultaneously create the possibility of social exclusion and multicultural coexistence. It clarifies the process for precipitating factors of exclusion and converting them into multicultural coexistence (For example, the media can be both a breeding ground for social exclusion and a vehicle for multiculturalism.). Specifically, in institutional analysis, civil rights, immigration, social participation, education, and structural analysis, elections, public opinion, social movements, media, academia and commentaries are used, and in normative analysis, religion and culture, historical awareness, foreign policy, and international society are used as examples. Clarifying the ambiguity of social foundations enables policy-oriented analysis of how multicultural coexistence can be achieved by promoting social exclusion under any social foundation, including norms, rather than just normative discussion of avoiding exclusion and encouraging inclusion. Since this research requires not only examination of individual cases but also international empirical research and international comparison, we conducted joint research in collaboration with researchers from the United States, the United Kingdom, France, Poland, China, South Korea, Philippines, Indonesia, and Malaysia.

In this study, we focused on social infrastructure, such as civil rights, immigration, social

participation, education, elections, public opinion, social movements, media, academia and discussion circles, religion and culture, historical perceptions, foreign policy, and the international community. In a liberal society, it is difficult for a group that openly advocates social exclusion to completely reject the claim. Further exploration of individual cases of social exclusion does not in itself theorize the process of multicultural conviviality. In this study, we analyzed social exclusion and examined the factors that constitute the resources, mobilization, and psychology of social exclusion.

In some cases, social exclusion is justified by the historical context in which each country is located; in other cases, social exclusion is internalized in the social movements of xenophobic groups, issues of hate speech, culture, religion, and education. Moreover, historical perceptions, foreign policy, and perceptions of the international community themselves can lead to specific social exclusion. Therefore, in this study, we analyzed each social infrastructure as a problem from the viewpoint of the orientation to multicultural coexistence.

3. Outline of research (Including study member)

The purpose of this study is to examine the construction of social infrastructure essential for realizing a multicultural society from multiple approaches, including case studies, data analysis, and international comparative research, and to clarify its mechanism. The case studies cover three areas: institutions (Citizenship, immigration, education and social participation), structure (Elections, public opinion, social movements, media, academic circles), and norms (Religion, culture, historical perceptions, foreign policy, and the international community), and consider (1) exclusion and (2) factors that promote symbiosis, and (3) mechanisms that direct exclusion toward symbiosis. And, this paper adds empirical research using data analysis and international case comparison of 13 countries in cooperation with overseas members. We comprehensively studied social infrastructure supporting multicultural conviviality society from both quantitative and qualitative aspects, and examined the political and social potential of "multicultural conviviality democracy".

Specifically, the institutional analysis group, structural analysis group, and normative analysis group conducted case studies, the data analysis group conducted multilateral comparisons based on data analysis, and the international comparison group conducted international comparison case studies. Case analysis groups, data analysis groups, and international comparison groups cooperated to verify individual cases, construct and analyze a quantitative database (Text Mining and Survey Experiments), and make a systematic international comparison.

As research results, panels were established at international conferences (World Social Sciences Forum), and in parallel with this, three international symposia were held from FY 2017 to FY 31. International symposiums not only invited overseas members, but also held sessions for young researchers and open recruitment sessions, and sessions were organized by excellent researchers from Japan and overseas, with attention paid to strengthening international collaboration and international dissemination of research results. As a summary of the research results, 'Rebuilding a symbiotic society' (Four volumes in total) is being published (Currently 3 volumes have been published.), and as a result of the international symposium, research books in English are scheduled to be published. Social exclusion and multicultural conviviality are interdisciplinary areas, and since each country has similar problems, the interest and attention of researchers at home and abroad is also great. Around 50 researchers from overseas participated in each international symposium and actively discussed and exchanged opinions. Through the three international symposiums in total, we believe that the

symposium had a significant ripple effect on other researchers and research fields overseas.

4. Research results and outcomes produced

This study focused on the ambiguity of social infrastructure of exclusion and inclusion, and studied a method for directing social exclusion to multicultural coexistence. Focusing on each social infrastructure, case studies were conducted from systems, structures, and norms, and the establishment of a comprehensive social infrastructure was examined based on data analysis and international comparative studies.

As a result of the research, (1) it was possible to examine the methods for the prevention of social exclusion and multicultural symbiosis through the action of a broad social infrastructure including norms, instead of focusing on normative discussions, by approaching social exclusion from the social infrastructure. This paper examines the construction method of symbiotic discourse as a method for deterring exclusion and coexistence, instead of easily escaping to normative discussion in the context of immigration policy, racism, social exclusion through media, political consciousness, etc. (2) Rather than focusing on specific institutions and structures, we focused on the combined effects of institutions, structures, and norms within society as a whole and conducted a more comprehensive study. Specifically, we examined the historical formation process of racism, xenophobia, and anti-racism, and the process of making international norms into domestic norms. (3) By introducing data analysis and international comparison, we were able to produce research results with higher verification and validity. Specifically, he conducted quantitative research on political awareness and political discourse, and conducted integrated research to reinforce qualitative research. (4) By approaching from the social infrastructure, we concretely examined what kind of systems and norms should be constructed in the future based on the current social structure. It also produced practical research results that were highly policy-oriented. Though it overlaps with the result of (1), the tendency and the process in which the symbiosis discourse is easy to form and fix were studied empirically. At the same time, the establishment of panels at international conferences (World Social Sciences Forum) was promoted, and international symposia were held three times in total from FY 2017 to FY 31. International symposiums not only invited overseas members, but also held sessions for young researchers and open recruitment sessions, and sessions were organized by excellent researchers from Japan and overseas, with attention paid to strengthening international collaboration and international dissemination of research results.

Also, as a summary of the research results, *Horitsu Bunka Sha* is promoting the publication of 'Rebuilding a symbiotic society' (Four volumes in total) (Currently 3 volumes have been published.). As a result of the international symposium, a research book in English (Routledge) will be published.
