

< Major Changes, etc. in the Call for Proposals for Fiscal Year 2027 >

(1) Schedule for the Call for Proposals

○The main future schedule for the FY2027 call for proposals for the Grants-in-Aid for Scientific Research -KAKENHI- (for the FY2026 call for proposals for the Grant-in-Aid for Research Activity Start-up and the Fund for the Promotion of Joint International Research) to be made in fiscal year 2026 is tentatively as follows.

- \*3 The adoption or rejection of newly proposed projects will be notified to their Principal Investigators via the KAKENHI electronic application system before or on the day of provisional grant decision.  
When you receive a Notice of Review Results indicating “adoption” of your project, you can make advance preparations for the commencement of your research project; however, as before, please conclude necessary contracts, etc. after provisional grant decision.
- \*4 Timing of provisional grant decision may change, depending on the passage of the government budget and other circumstances.
- \*5 The schedule in parentheses means the timing for issuing Notices of Review Results of “Preliminary Screening.” “Preliminary Screening” is not conducted for Transformative Research Areas (A).
- \*6 For Home-Returning Researcher Development Research, “provisional grant decision with conditions” will also be made.

(2) Relaxation of the Restriction on Parallel Grant Application/Receipt for the Grant-in-Aid for Challenging Research (Exploratory) and Scientific Research (C)

- In order to further expand support for early-career scientists, we will relax the restriction on parallel submission of research proposals and parallel grant receipt for those aged 39 or younger with regard to the Grant-in-Aid for Challenging Research (Exploratory) and Scientific Research (C). We plan to consider the applicable scope of the relaxation of the restriction on parallel grant application/receipt, while taking into account the burden and effectiveness of review in light of the future status of applications and paying attention to career development as researchers and other matters. (3) Revision to the Review Method for the Grant-in-Aid for Challenging Research (Pioneering) (Tentative)

- We plan to revise the review method for the Grant-in-Aid for Challenging Research (Pioneering) and introduce a “two-stage document review.” (Please refer to the FY2027 Application Procedures for Grants-in-Aid for Scientific Research for the relevant category (call for proposals scheduled to begin in July))

(4) Increased Continuity from the Grant-in-Aid for Challenging Research (Exploratory) to the Grant-in-Aid for Challenging Research (Pioneering) (Confirmation of the “Development Potential from Research Projects Adopted in the Past” and the Introduction of “Research Proposal Submission in the Fiscal Year Previous to the Final Fiscal Year of the Research Period of an On-going Research Project”)  
(Tentative)

- We plan to make necessary revisions so that in the call for proposals and review under the “Grant-in-Aid for Challenging Research (Pioneering),” we can confirm development potential from research projects adopted in the past under the “Grant-in-Aid for Challenging Research (Exploratory).” We also plan to introduce “research proposal submission in the fiscal year previous to the final fiscal year of the research

period of an on-going research project” for research projects adopted under the Grant-in-Aid for Challenging Research (Exploratory). This will enable researchers to make application for the Grant-in-Aid for Challenging Research (Pioneering) with respect to these projects in the fiscal year previous to the final fiscal year of the research period. Accordingly, relevant descriptions and forms are planned to be added to the Application Procedures for Grants-in-Aid for Scientific Research, Research Proposal Document, and Rules Concerning the Review and Assessment.
